

Habit 1: Be Proactive





Before/After School Care

Eastwood Elementary School hosts safe, convenient, and affordable before-and after-school care for children in Kindergarten through 5th grade. The program is run by Boys & Girls Clubs of Greater Southwest Michigan. All of the staff are trained to provide safe, inclusive places where kids can build confidence, explore interests, and enhance skills. The Boys & Girls Clubs before and after-school care curriculum includes

an education program designed to prepare youth to be competitive graduates. A leadership and character development program empowers youth to become good citizens. A healthy lifestyle program encourages positive behaviors and stress manage-



ment. To participate in the program there is a one-time membership fee of \$5 per student for the entire school year. Shuttle service will be provided to and from Congress, Wall, and Wenzel Schools.

District Improvements

Sturgis Public Schools is committed to providing safe, comfortable, and engaging learning environments for our students. Summer gives us a unique opportunity to maintain and improve our school grounds, buildings, and equipment. Here is a list of our 2023 Summer projects:

- Built new inclusive playgrounds at Jerolene School and Sturgis Central Commons.
- Painted and installed new flooring in classrooms at Congress Elementary School, Wall Elementary School, Wenzel Elementary School, in the EDGE Classroom and Office at Sturgis High School, and in the Boardroom at Sturgis Central Commons.
- Replaced student chairs, tables, and desks at Congress, Wall, and Wenzel Elementary Schools with new flexible furniture.
- Replaced chairs and tables in the Boardroom at Sturgis Central Commons with new flexible furniture.
- Upgraded heating, cooling, and ventilation throughout the district, and added air conditioning to the main gym and auxiliary gym at Sturgis High School.
- Renovated a second floor wing at Sturgis Central Commons for ISD special education programming.

School

Safety Enhancements

Sturgis Public Schools is committed to providing safe learning environments for our students. We were fortunate to be able to take advantage of several safety grants this year. Here is a list of some of our safety upgrades:

- Adding a half-day School Resource Officer (SRO) who will focus his efforts on serving our Elementary Schools.
- ♦ New building crisis plans.
- ♦ New classroom emergency flipcharts.
- Replaced old non-robust interior doors and frames with new robust interior doors and frames throughout the district.
- Purchased 50 new portable two-way radios for communication and emergency response.
- Installing Raptor district-wide, which is an integrated school safety software that enables schools to prevent, prepare, respond and recover from an emergency.
- Replacing select surveillance cameras throughout the district
- Adding a set of double doors at Sturgis Central Commons to separate the preschool programs from the rest of the building.
- Adding seven new door access card readers that select entrances throughout the district to support our efforts of moving away from keyed entry.

Family Rights

Family Educational Rights and Privacy Act

Parents may inspect and review educational records of their students within 45 days of making a written request to the building principal.

Parents may request that records be amended by the school where there is a belief that inaccuracies exist. Such requests shall be made in writing and directed to the building principal.

The school may disclose the contents of a student's educational records to school officials having a legitimate educational interest without parental consent. School officials include administrators, supervisors, counselors, teachers, support staff members, a school board member, or a person or company contracted by the district to perform a special task.

The school may release directory information without parental consent, unless the parent has filed a written objection to releases with their building principal. Directory information about a student includes: Name, address, telephone number, date of birth, photograph, major field of study or grade, participation in school activities, dates of school attendance, honors and awards, and other general information generally found in yearbooks.

Parents have a right to file a complaint with the Family Policy Compliance Office in the U.S. Department of Education.

The above parental rights transfer to the student when he or she turns 18 years of age or enters a post-secondary educational institution at any age.

Protection of Pupil Rights

Protection of Pupil Rights Amendment (PPRA) governs the administration to students of a survey, analysis, or evaluation that concerns one or more of the following eight protected areas:

- Political affiliations or beliefs of the student or the student's parent;
- 2. Mental or psychological problems of the student or the student's family;
- 3. Sex behavior or attitudes;
- 4. Illegal, anti-social, self-incriminating, or demeaning behavior;
- 5. Critical appraisals of other individuals with who respondent have close family relationships;
- 6. Legally recognize privileged or analogous relationships, such as those of lawyers, physicians, and ministers;
- 7. Religious practices, affiliations, or beliefs of the student or student's parent; or
- 8. Income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program).

If such surveys are funded by the U.S. Department of Education, prior written parent approval must be received before the survey is administered. Non-department funded surveys may be conducted without written parental permission provided there is prior notification to the parent indicating the purpose, approximate dates of administration and an opportunity for the parent to opt their student out of participation.

Highly Qualified Teacher

Our district receives funding from many resources, one of which is Title I, Part A, a grant provided by the federal government. As a requirement for receiving funds under this program, each school must meet the guidelines for "highly qualified teachers and paraprofessionals" in each subject area using a system approved by the Michigan Board of Education.

Parent(s), may request information on your child's teacher(s):

- Certification for grade level and subject.
- Emergency or provisional status.
- BA major and graduate degrees.
- Whether a paraprofessional teachers your child.

The district will notify you when your child is being taught for 4 consecutive weeks by teachers NOT highly qualified.

Educational Services

Educational Services to Homeless and Migrant Children

Homeless Students: Students who qualify as homeless by state guidelines are eligible for immediate enrollment and educational services, with or without required entry documents.

Migrant Students: Students whose families have moved within the past 36 months to obtain temporary employment in agriculture or fishing are eligible for regular school year and summer programs designed to provide basic instruction in the core curriculum. Priority will be given to those who have moved during the academic year and are in jeopardy of not meeting the academic standards of the core curriculum.

Nondiscrimination Policy

In compliance with the Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, the Americans with Disabilities Act of 1990, and the Elliott-Larsen Civil Rights Act of 1977, it is the policy of the Sturgis Public Schools District that no person shall, on the basis of race, color, religion, national origin or ancestry, sex, disability, height, weight, or marital status be excluded from participation in, be denied the benefits of, or be subjected to discrimination during any program, activity, service or in employment. Any person believing that the Sturgis Public School district or any part of the school organization has inadequately applied the principles and/or regulations of any of the following principles have the right to file a grievance:

- Title VI of the Civil Rights Act of 1964, which prohibits discrimination on the basis of race, color or national origin;
- Title IX of the Education Amendments of 1972, which prohibits discrimination on the basis of sex;
- Section 504 of the Rehabilitation Act of 1973, which prohibits discrimination on the basis of disability:
- Title II of the Americans with Disabilities Act of 1990, which prohibits discrimination on the basis of disability.
- Elliott-Larsen Civil Rights Act of 1976 prohibits discrimination in Michigan on the basis of religion, race, color, national origin, age, sex, height, weight, familial status or marital status in employment, housing, education, and access to public accommodations;
- Age Discrimination Act of 1975, prohibits discrimination on the basis of age

Pesticide Policy

Sturgis Public Schools has adopted an Integrated Pest Management program. Inherent with this are the District's efforts to reduce pesticide use as much as possible. While it may occasionally be necessary to apply a pesticide, this program **does not** rely on routine pesticide applications to resolve problems. We use various techniques such as habitat alteration, sanitation, mechanical means, exclusion, etc. to prevent pest from becoming a problem.

As required by Michigan law, you will receive advanced notice of non-emergency application of a pesticide (insecticide, fungicide, or herbicide), other than bait or gel formulation, which is made to the school, school grounds, or buildings. This advance notice of a pesticide application will be given 48 hours before the application by the following two methods:

- Posting at the primary entrances to your child's school.
 The entrances that will be posted are the main entrance and those that have a sidewalk that leads directly to a parking lot.
- Posting in the common area located by the main office of the school.

Please note that notification is not given for use of sanitizers, germicides, disinfectants or anti-microbial cleaners. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be promptly notified following any such application, via the two posting methods identified (above).

You may review the school's Integrated Pest Management program and records of any pesticide application upon request by contacting **Ben Currier** at bencurrier@sturgisps.org or 269-659-1590.

Parents or guardians of children attending the school are also entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first class United States mail postmarked at least 3 days before the application, if they so request. Parental Involvement Plan

Asbestos Policy

The Local Education Agency (LEA) or Sturgis Public Schools is required under Federal law to maintain a copy of the management plan in the administrative office and each school building. Sturgis Public Schools must notify in writing; parents, teachers and employee organizations at least once a year regarding the management of the asbestos in the schools. The management plan shall be available during school business hours for review without cost or restrictions by the public, including teachers, other school personnel and parents.

Periodic surveillance (inspections) of asbestos containing materials will be completed every six months. Ben Currier is the designated person for the school district. If you have any questions, please call (269) 659-1590.

Military Release Policy

Two federal laws and one Michigan law require the Sturgis Public Schools District to provide military recruiters, upon request, the names, addresses, and telephone numbers of high school students. A parent/guardian or 18-year-old student may exercise the option to withhold consent for the release of this information to military recruiters by contacting Sturgis High School at (269) 659-1515 and following a set of procedures.

Photography Policy

Photos and/or video footage for the purpose of media are taken of school children throughout the year. If you do not want your child to appear in any of the published pieces, please advise the principal at your child's school.

Programming

GSRP Preschool

Great Start Readiness Program (GSRP) is a low-cost or free preschool program for income-qualified four-year-old children who live in the Sturgis Public Schools District or reside in St. Joseph County, GSRP features qualified teachers, bilingual support staff, and free transportation. The full-day program is offered at Jerolene School and Sturgis Central Commons.

Children must be four by September 1, 2023. Students turning four between September 1, 2023 and December 1, 2023 may apply for a waiver. Over-income families may attend if there are spots available after all qualified children are enrolled. Apply at www.helpmegrowstjoe.org to enroll your child. For more information about the program, call (269) 659-1570.

EDGE Alternative Education

An enhanced version of Alternative Education is offered at Sturgis High School through the Education for a Greater Experience (EDGE) program. EDGE is taught and mentored by two certified teachers in a newly renovated classroom at Sturgis High School. A secretary dedicated to supporting the EDGE students' needs rounds-out the EDGE staff.

Early Middle College

If tuition-free college sounds good, Sturgis High School's Early Middle College (EMC) program might be for you. EMC allows students to earn their high school diploma and their Glen Oaks Community College associates degree concurrently and in half the time. Adult Education


